

INTRODUCTION

Do you have 2020 Vision?

Over the past five years this church has come a long way, but it did not happen by accident. In 2016, this church put together a four-year plan (2016-2020) and made significant progress toward implementation. With that plan as our foundation, we articulated a five-year plan in 2018 (2018-2023) to envision the direction we, as a congregation, would like to be headed. Since articulating that vision, we have assessed the plan frequently, adopting implementation goals and making progress toward our congregational mission (articulated on the next page).

We have done much in the past few years; but in order to do so, we had to have a vision for where we are going, what we are doing and who we want to be as God's missionaries in this place. That vision has led us here, and that visionary identity will lead us through 2020 and beyond. This church has 2020 Vision.

The Annual Report you hold in your hands is the result of that 2020 Vision. Because of our vision, this year we have been able to do our part to impact God's world in wonderful ways. The reports that follow discuss how we have been a force for Good in God's world this year. As you read them, I hope you sense the energy and "vision" driving these ministries forward.

Some powerful statistics from 2019:

- This year CUCC served 1540 meals at Loaves and Fishes
- In January the monthly Food Bank crew bagged 4300 lbs. of potatoes for distribution
- We served three complete meals at Ronald McDonald House this year
- We sent 9 youth and four adults to summer camp
- We sent 9 youth and two adults to the Conference Youth Event
- We sent six delegates to the Conference Annual Gathering
- We sent three staff members to continuing education events
- We sent \$5750 to Chiapas for transformative impact on our ministries there
- We raised over \$5000 for Mobility Worldwide (PET Project) for our Spring Mission Project
- 8 youth participated in Confirmation classes
- Monthly our Men's, Women's, High School and Middle School groups gathered for education, mission work and fellowship
- We held three 4-6-week Wednesday evening Bible Study sessions
- Weekly our Chancel Choir, our Bell Choir and our Quilters all meet to pursue their individual ministries with CUCC.

PURPOSE:

To provide leadership for the Council and Congregation, working to ensure that the Constitution and Bylaws are followed, that the Mission Statement is lived out, and that components of the Strategic Plan are executed; to foster a loving, Christian environment consistent with our stated Core Values.

Highlights:

We began the year 2019 with a historic vote to live out our mission as an Open and Affirming church. The Inclusion Committee, led by new leader Alisa Lau-Sieckman, and with several new members, forged forward planning new educational opportunities and involvement in community events. A highlight was a CUCC booth in the Pride Fest event in August.

The church had a new roof installed in the spring; the majority of it paid for by insurance. A big thank you to Buildings & Grounds Ministry Team leader John Bullerd for helping see this task got completed and for keeping our facility and grounds in tip-top shape. Another thank you goes to Fred Malicoat for working with MODOT in getting the drainage problem fixed along our entrance and driveway, with new rock to stabilize this improvement.

The Membership & Care Ministry Team, led by Stefanie Zimny, were instrumental in planning, designing and arranging installation of our new sign that faces I-70 Dr NW and I-70. Along with new directional signs along the church driveway, this project is part of a focus to improve CUCC's visibility (along with LODO's) to the community.

This fall we celebrated the 50th Anniversary of our sanctuary building and what a weekend it was! Thank you to the Heritage/Archival Committee, led by Doug Privitt, for planning all the fun activities as well as the inspirational Sunday service, which featured 2 previous Pastors of our church, Jerry Jordan and our Pastor Emeritus, Fred Brandenburg.

To honor 50 years of services and mission at CUCC, the Church Council approved a fundraising drive which we called "50 for 50". The goal was to raise \$50,000 in 50 days, ending at Advent, to fund improvements, upgrades and technology for our church's future. As always, you, the faithful congregation of CUCC, responded with a grand total of \$66,292.40! This fundraising project was led by the Finance & Stewardship Ministry Team, led by George Zimny, and they did a fantastic job. A personal thank you to everyone who gave of their time and treasure to help ensure our church's future for another 50 years!

Finally, a huge amount of praise needs to go to Pastor Rick, for the numbers of hours and amount of effort he invests in his role as Pastor and Teacher. His leadership and friendship are without bounds. His leadership was most beneficial in helping each Ministry Team create and publish their Ministry Team Description and Guidelines which will facilitate an easier transition for new team members. His work with the By-Laws Review Committee will help bring needed upgrades to CUCC By-Laws that will be presented to Council this spring. But most of all, his belief in "intentionally planned ministry". To quote Pastor Rick, "Excellent ministry happens around well executed plans."

Thank you also to the fantastic CUCC staff; April Rothweiler, Kristin Veteto, Raj Tolani, Lloyd Viehland, Amy Crousore, and Erika Maltsbarger.

In closing, 2019 has been a busy and productive year. Accomplishments are only possible with the synergy of all our Church Council. Thank you Christine Staelens, Doug Privitt, Jane Duncan, John Bullerd, Stefanie Zimny, George Zimny, Pat Forward, Jolene Kirchoff, Val Schoeneberg, Mahree Skala and Pete Jaberg. Your next moderator, James Melton, is an excellent administrator and leader, and CUCC will thrive under his leadership.

VICE MODERATOR: VISION TEAM

Members: The Vision Team is comprised of one representative of each of the seven Ministry teams, the Pastor, and the Vice Moderator, who chairs the Vision Team. 2019 members included: Pastor Rick Oberle, James Melton, Sue Ann Schaefer, Emmalee Heine, Lena Muench, Jolene Kirchhoff, Audrey Lasley, and JoEllen Grace. Also attending specific meetings and giving input was Erika Maltzberger, Director of LODO, and Kristin Veteto, Music Coordinator.

The Vision Team met on September 30, and each area followed up with a final report. A Congregational meeting was held on October 27 to present the revised Five-year Strategic Plan and the Ministry Team action items.

Significant additions and revisions include:

Nurture and Education

- In 2020, there will be Intentional Planning by class leaders to implement the Rubric in each Sunday School classroom, Preschool-Eighth Grade.
- In 2020, there will be growth and development in the Young Adult Group, and the Middle and High Youth Programs at CUCC.
- In 2020, Vacation Bible School (VBS) will be advertised to the greater Columbia Community, including signage at road frontage and flyers distributed in church's neighborhood.
- In 2020, members of Nurture & Education Ministry Team and all church members will be encouraged to attend LODO activities to show support for this ministry (i.e. Graduation, Christmas Program, Book Fair)
- Nurture & Education Ministry Team will participate in upcoming anniversaries in 2021 and 2023, with special faith formation activities.

Membership and Care

- In 2020, create a ministry program (Stephens Ministry or similar program) and evaluate the benefits it may have for our congregation.
- In early 2020, develop a plan to identify the needs of our congregation and how they can be addressed.
- In early 2020, we will be more intentional about addressing the needs of our homebound members.
- Develop a plan to include newly confirmed students into the life of the congregation.
- Evaluate our latest pictorial directory to determine if we have the requisite 15+ photo sittings to have a new directory published.
- Work with the Council and other Ministry Teams to evaluate transportation challenges and opportunities for our members.

Finance and Stewardship

- Review other Vision Items articulated by the congregation and Church Leadership and develop action/implementation plans
- Increase Joyful giving. Define a number or percent.
- Participate in the development and define a building plan for physical space
- Define our Historic Funds by the end of 2019
- Set 5-year goals (2023) for Historic Fund balances and market them to the congregation

Music and Worship

- In 2020 we will make updates to the sanctuary technology, equipment, and lighting to enhance the overall worship experience.
- In 2020 we will continue to develop a diverse worship experience through song, dance, drama, and other performing arts.
- In 2020 we will develop an intentional program to involve youth and young adults in worship.
- In 2020 we will develop a plan to invite musicians from other churches to join us for Sunday morning worship and/or we will travel to smaller congregations (focusing on UCC) and sing/ring for their worship service.
- In 2020, we will host a musical program for the community.
- We will develop a plan to work with LODO to integrate more music into their program
- We will develop a plan to work on integrating music into the Sunday School classrooms
- We will make special plans to participate in the 100th anniversary of CUCC in 2023 through music and other performing arts programs.

Outreach and Advocacy

- Increase Outreach expenditures each year over the next 5 years with a goal of spending 10% of our income on Outreach and Advocacy by 2023 (or before)
- Further develop our relationship with Global Ministries and Chiapas
- Further develop our relationship with Camp MoVal (youth and adults)
- Identify an advocacy project that reflects CUCC's values and encourage the congregation to participate
- Establish a separate team to promote Our Church's Wider Mission; increase congregational awareness of, and our contributions to, OCWM each year with a set goal by 2023

Little One's Day Out

- Work with CUCC planning teams to improve LODO signage at the road to include a more prominent sign for LODO with an updated, professional LOGO.
- Work with Buildings and Grounds to:
 - *Obtain bids for replacing floors in Lambs, Lions, and Leap Frogs classrooms.
 - *Update/remodel bathroom in the hallway.
 - *Develop a maintenance plan for regular professional pest control inside LODO and on the playground that uses chemicals safe for children.
- Explore ways to encourage CUCC members to share time and talent by:
- Having members volunteer in classrooms by reading books, sharing their hobbies, or speaking about their careers.
- Having members assist to plant a garden in which LODO students can learn about planting and healthy foods.
- Work with technology team to allow for access to LODO documents by Director when working outside the building.

Inclusion Initiative

- In 2020 the CUCC Inclusion Initiative will continue to host education events for the membership of CUCC
- In 2020 the CUCC Inclusion Initiative will plan to participate in community-wide opportunities and explore participation in these activities

- In 2020 the CUCC Inclusion Initiative will network with other ministry teams to develop an inclusion calendar that coordinates with other teams' events.
- In 2020 the CUCC Inclusion Initiative will explore additional promotional and publicity materials, signage, social media, flyers, etc. that will make the congregation, community and conference aware of our presence and ministry.
- In 2020 the CUCC Inclusion Initiative will intentionally connect with and build a network with other ONA churches and congregations.

In 2020, the Vision Team will continue to review the Mission Statement and Strategic Plan to determine if any revisions are required and to set priorities for 2021. They will also be charged to develop plans for the 20th Anniversary of our LODO Ministry (2022) and the 100th Anniversary of this congregation (2023).

SECRETARY REPORT – ANNUAL MEETING MINUTES

Annual Meeting Minutes: January 27, 2019

Note: These are the minutes from the 2019 Annual Meeting and will be voted on for acceptance at the 2020 Annual Meeting.

Judi Privitt opened the meeting at 11:40 am in the sanctuary and established quorum. Steve Keithahn discussed the 2.5 year process of the Inclusion Initiative Committee. It began in the Fall of 2015 with revitalization and has been a journey until today where the congregation will vote on a covenant.

James Melton discussed the covenant statement and the process of how the statement was completed and ready to bring forward to the congregation for a vote.

A motion for acceptance was submitted by Church Council. Discussion followed. Following discussion a motion to end discussion was proposed by Lena Muench and seconded by Pete Jaberg. Motion carried.

The vote for acceptance of the Open and Affirming covenant was then taken via paper ballot. Following the vote, a motion to recess was brought forward and moved. The congregation sang "Peace on Earth" and then made their way to Fellowship Hall to enjoy lunch while the votes were being counted by Paula Wilson and Sue Ann Schaefer.

The meeting resumed with a motion by Jolene Hackman and second by Jim Loveless in Fellowship Hall. Judi Privitt announced the results of the vote on the Open and Affirming covenant. There were 130 votes tallied and 111 "yes" votes and 19 "no" votes.

Cliff Beckman welcomed everyone in attendance for the Annual Meeting and Chili Cookoff. There were 20 entries in the chili cook-off. Cliff thanked all of the chili cooks as well as those who provided the desserts. The three "tasting" judges were Gary Sieckman, John Bullerd, and Elaine Trout. A gift of a commemorative glass was given to each of the judges. The following were the chili winners:

- 2nd place: Paul Sanderson-"Another Tailgate Chili"
- 1st place: Kurt Heine -"Mild Meat Chili"

Each winner was given a gift and Kurt was also given the Golden Ladle Award. Thanks to Cliff's daughter, Jen, for making gifts for the winners. Pastor Rick said a prayer before the meal.

Business Meeting

The meeting was called to order by Moderator, Judi Privitt. 2018 Annual Meeting minutes were discussed and motion to approve was made by Llona Weiss, and seconded by Barry Kirchhoff. Motion carried.

Pastor's Report

Financial Report

Doug Privitt discussed the financial reports and reported that \$24,000 was deposited in 2017 that should have been reported during 2018. The actual receipts during 2018 should be \$281,000. When compared with 2017 we are okay, financially. Doug suggested we look into our hearts when considering our contribution.

Vision Team Report:

John Graves reported that a new team will convene in 2019 and discuss a 2019 budget strategy regarding financials with emphasis on the bottom line. John expressed no big concerns.

Inclusion Initiative Report:

James Melton reported that this committee will meet another time to discuss next steps following the result of vote taken today.

Buildings & Grounds Committee Report;

Paul Sanderson reported that there were lots of improvements in 2018 including the Fellowship Hall. Paul reported that roof should be completed in spring 2019. In addition, there will be a review of the sound in the Fellowship Hall, as well.

The meeting was called to order by Council Moderator John Graves at 11:37 a.m. after determining a quorum was present for the meeting.

Christine Staelens, Council Treasurer, led the discussion on the 2020 CUCC proposed budget. Christine pointed out that a 5.29% increase in Joyful Giving was necessary to support the 2020 budget being proposed to the congregation. There were no questions from the congregation.

Jim Loveless made a motion that the congregation approve the proposed budget as submitted. The motion was seconded by Jolene Kirchhoff. The motion was approved by the congregation as presented.

John Graves extended his gratitude to Christine Staelens, Doug Privitt, and George Zimny for their work in preparing the 2020 budget.

Ed Kaiser made a motion to adjourn the meeting. The motion was seconded by Doug Privitt. The motion was approved by the congregation.

OVERVIEW OF 2019 FINANCIALS / TREASURER

PURPOSE: To assist the church council by maintaining financial records and providing monthly management accounts to assist in financial decision making.

2019 Financial Highlights:

- Cash and investments increased by \$103,205 over December 2018, an increase of 33.7%. The market value of our investments increased 21.6% which more than offset the 3.18% decrease we experienced in 2018. Our cash balances increased \$51,933 due to the strong Joyful Giving and increase in Designated Fund balances.
- Joyful Giving exceeded our budget goal by \$10,187. The 2019 budget called for an increase of \$32,394 over the 2018 actual which is an increase of 11.5%. The faith and generosity of our members allowed us to exceed our budget goals.
- Our budgeted expenses for 2018 were \$323,532 and our actual expenses were \$319,693 despite out of pocket expenses for replacing the roof. Notable budget variances are:

Camp Scholarship Fundraising and Camp Scholarship expense – Fundraising was under budget by \$2,231.50 and expense was under budget by \$1,429.71. This is the first year budgeting for these items since camp scholarships are typically paid from the designated fund. We had fewer students attending camp this year.

Bank Service Fees – When the budget was approved we did not consider the fees associated with using Kindrid for electronic giving. A line item for Kindrid fees has been added to the 2020 budget.

Building Maintenance – Over budget by \$7,824.11. Much of this is the portion of the roof replacement that was not covered by insurance.

Administrative Assistant salary – April was on maternity leave for part of the year so this line item was under budget by \$2,750.25.

Year End Bonuses – This is an item that was not budgeted. As we approached the end of the year, we evaluated our financial condition and voted to pay bonuses to staff (not including LODO staff since they budget for their staff).

Heritage Team expenses – These expenses are largely for the 50th anniversary celebration. We did not include an estimate for these expenses in the budget.

The 2020 budget was approved at the November congregational meeting.

This is my final report as treasurer. I would like to thank Raj for her diligence and dedication to her duties, George and the Finance and Stewardship committee for their guidance and all of Church Council for the engaging discussions and feedback. It has been a pleasure and honor to serve the past four years.


RECORDING TREASURER _

BUILDING & GROUNDS MINISTRY TEAM _

PURPOSE: To meet accessible requirements; to protect our investment in the assets of the church; to provide a comfortable, clean and safe place to carry out the programs of the church; to provide access to the church; parking for staff and participants; an aesthetically pleasing environment; to provide comfort, security, safety, and sanitation; to keep assets in good condition and repair.

Activities and Highlights:

A Building and Grounds Committee was formed mid-year. The members include; John Graves, Doug Privitt, Charlie Marcks, Lloyd Viehland, Glenn Duermeyer, Fred Malicoat, Cliff Beckman, Hugo Wilmsmeyer, and John Bullerd.

Completed Projects & Repairs:

- A new roof was installed on the Church and the pavilion
- The kitchen sanitizer was repaired
- The remaining stackable dining room chairs were purchased
- Water mixers were installed to meet LODO safety inspection standards
- New door locks were put on majority of the doors inside of the church building for increased security
- A new lawn care service was contracted
- We received landscaping bids (from Mill Creek Landscaping and Rost Landscaping) for possible Spring landscaping project in 2020.
- The East canopy (by the Church office) was repaired after damage by City of Columbia Waste Department (at their cost).
- Ceiling and drywall repair was completed in the Sanctuary and upstairs classrooms
- A new garbage disposal was installed the back kitchen sink and new faucets were installed in the front kitchen sinks (Thank you to those who generously donated the materials, time, and labor.)
- HVAC filters were purchased and installed with materials, time, and labor donated by Charlie and Brent Marcks, and Mike Rapp (*Thank you!*)
- HVAC repairs were done: main blower and draft blower were replaced
- The driveway drainage issue was resolved with regrading and adding rock to prevent water crossing and freezing over the driveway

A special thanks to the committee members who helped clean up and mow the South bank, and all the other things that needed done throughout the year.

BYLAWS MINISTRY TEAM

The Task Force was established to review and determine what, if any, changes needed to be made to the church's constitution and bylaws. The following members have worked hard and carefully over the past seven months to make a document to submit to the Council and Congregation for consideration: Judi Privitt, Keith Birkes, Jim Loveless, Brent Marcks, James Melton, Lauren Helmrich, Bryan Crousore and Pastor Rick Oberle, ex-officio.

We had our first meeting in June and have met for a total of 8 times since then. Early on, we discovered a number of issues where our bylaws did not reflect the way we are actually doing things, did not agree with other fundamental documents, or were restricting our ability to act in the most effective, mission-oriented way.

We discovered that our corporate entity is still "The Chapel United Church of Christ." In our historical files, we found that the proper paperwork to legally change our corporate identity with the Secretary of State of Missouri was completed in 1970. However, those documents were never submitted to the Secretary of State. While that may seem like a unnecessary bit of legalese, there are any number of potential scenarios where that could cause us trouble. We will submit new documents to the current Secretary of State as soon as a new constitution with the correct name is adopted that can accompany those documents.

We decided early on that we needed to do a full revision of both the Constitution and the Bylaws and not merely do a few amendments.

We have been through several drafts, have worked long and hard on a couple of fundamental issues, and are now putting some final editorial and formatting touches to what we hope will be our final draft to submit to the Church Council.

We have outlined a timeline for 2020. We will submit a final draft to the Church Council at their meeting in January. After their review and suggestions, we will make any further changes that they give us, and revise the draft as necessary. We will host a number of educational or informational events in the late winter and spring so that all are aware of what they will be considering. Assuming favorable feedback at those events, we will request that the Council call a Special Congregational Meeting in the Spring to formally consider and adopt the revised Constitution and Bylaws or send them back to us for further work.

If anyone has questions or would like to know more about what we have been doing, please ask me. I love to talk about this kind of nitty-gritty churchy stuff.

- Souper Bowl Fundraiser for the local Food Pantry was held on Sunday, February 3, 2019, with \$213.54 raised.
- In February, Linda Neal updated the Children's Activity bags for use during worship, with new and different items.
- The Rubric, developed to show intentional teaching in the Preschool 8th grade Sunday School classes, was mailed to all members in March, 2019.
- Children carried in Palm leaves at beginning of worship on Palm Sunday.
- N & E contributed to the church-wide fundraising event for PET, by sponsoring "PET Races" on April 14. Lloyd Viehland transported several PETs to CUCC for the race event, held in the parking lot at CUCC.

- Easter Sunday had 3 rotating sessions with story, crafts and games, ending with an egg hunt. The traditional balloon release was held during worship.
- Passed out Carnations to all the women in worship on Mother's Day.
- VBS Kick Off Sunday was held June 3, and VBS was held Sunday, July 28-Thursday, August 1, 2019, 5:45-8:00 pm. "ROAR" was the theme, with Lena Muench and Gina Pierson chairing. 54 kids attended VBS and there were over 40 volunteers. School supplies were collected for the VBS Outreach project. Dinner was served to all kids, families and volunteers, at no cost. Val Schoeneberg coordinated the meals each night of VBS, with the following church groups each helping out one night Nurture & Education Ministry Team, Men's Fellowship, Church Council, Youth group, and Women's Fellowship.
- Youth Parent Meeting was held on August 21, 2019, with all high school and middle school youth and their families invited to dinner, catered by Dickey's, followed by discussion and planning for the youth program at CUCC for the coming year.
- Safe Church/Healthy Relationships Training was held on August 25, following worship, for all volunteers who work with children and youth. 25 members attended.
- Rally Day, on September 8, opened with Sunday School beginning with Pastor Rick, and Kristin Veteto, in the Sanctuary, and then to stations for tattoos, a craft station, and a Bounce House.
- 3rd Grade Bibles were presented to Jackson Jaberg, and to 5th grader, Polly Fuller.
- CUCC 50th Anniversary, on September 22, was celebrated during the Sunday School classes by having a "Retro Games" event. A Time Capsule was created in honor of the celebration, with church members donating items. The time capsule has been sealed and placed in the back of the craft closet in the Sunday School wing, to be opened in 25 years, in 2044.
- A new Confirmation Class, 2019-2020, of three students began in October, 2019 with Pastor Rick leading.

OUTREACH & ADVOCACY MINISTRY TEAM

PURPOSE: To coordinate and encourage participation in local outreach activities; promote organizations included in the annual Outreach budget; promote support for Our Church's Wider Mission and the special offerings of the United Church of Christ; identify non-partisan issues for which advocacy may be appropriate.

Many CUCC members and friends contributed their time, talents and treasure to reach out into our community and the wider world in 2019. The activities listed below are a sample of these efforts.

Special Offerings and Contributions

CUCC was again a "Five for Five" congregation, supporting all 5 UCC campaigns—Our Church's Wider Mission, One Great Hour of Sharing, Strengthen the Church, Neighbors in Need, and the Christmas Offering (Veterans of the Cross). We held a special campaign to pay for and deliver 17 Personal Energy Transportation devices to disabled people overseas through Mobility Worldwide. In addition, we collected special offerings for the Food Bank of Central and NE Missouri (5th Sundays); Church World Service Tools and Blankets Sunday; the CROP Walk; and a special Christmas Eve offering to buy out medical debt for low-income people in rural Missouri.

Budgeted Support for Service Agencies

Through the congregation's generous support, \$20,000 from the general fund was disbursed to 12 local service agencies and 6 state, national and international organizations to assist their work in feeding the hungry, ministering to refugees, serving disaster victims, housing the homeless and providing spiritual support for people in their times of need. The special mission project provided \$5,750 in support to INESIN and Melel Xojobal missions in Chiapas, Mexico.

Gathering Supplies and Gifts

CUCC donated generously to several collection drives, including school supplies for local low-income children; 8 bags of warm coats, hats, gloves, and scarves for Warm Up Columbia; school supplies and hygiene kits to the Festival of Sharing; and Christmas gifts and food money for 34 local people in 9 families for the Voluntary Action Center Christmas Campaign. Volunteers took responsibility for collecting and delivering all these items.

Faithful Service

Many CUCC groups and individuals worked at the Food Bank on the second Tuesday of each month to package a total of over 9 tons of food. Crews of church members and friends helped Audrey Lasley serve an average of 125 portions to 80 homeless and low-income people each third Monday at Loaves and Fishes (Wilkes Blvd. Methodist Church). Twenty volunteers picked up 40 bags of trash and recycling on I-70 Drive NW near the church during Clean Up Columbia Day in April.

What is Our Church's Wider Mission? It is *not* an Outreach program, it *is* about identity. Our Church's Wider Mission (OCWM) is who we are as Christians, acting out love in God's World. OCWM is who we are as God's Children!

Where does the money go? When we remit our OCWM contributions each month, 80% of the funds stay here in the Missouri Mid-South Conference to undergird and support Camps MoVal and Shannondale, to support the ministries of the Conference, to support churches in need, to provide pastoral assistance for churches in the search process, to provide revitalization resources for churches seeking new growth and vitality.

20% of the funds we send in are remitted to the National Setting of the United Church of Christ where they are used to fund our missionary work overseas (such as the work being done in Chiapas); to provide resources for clergy and churches seeking growth and revitalization, to help churches who are struggling, to advocate for those who are disenfranchised and in need of God's healing love, to enable youth programming throughout the denomination, to change lives and transform the world into an image more reflective of God's passion for shalom.

Columbia United Church of Christ has committed to supporting God's work through our increased support of Our Church's Wider Mission each year. This is not outreach, this is who we are; God's Children making a difference in God's World.

CHIPAS MISSION REPORT

2018 was the beginning of the relationship between Columbia United Church of Christ and our Global Mission Partners in Chiapas. After a year of studying about the culture and climate of Chiapas, In October, 2018 seven CUCC members (and four from other churches) travelled to Chiapas for our first ever Mission Immersion Experience. It was quite an exciting time, as we learned about the people of Chiapas and the context in which they live. We contributed to the construction of the Bishop Samuel Ruiz Multipurpose Facility, the building which has been constructed in large part by members of the Missouri Mid-South Conference of the United Church of Christ. Our hearts were changed forever by our experiences in Chiapas.

In 2019, we continued our relationship with the Mission agencies in Chiapas. There are two agencies we work with directly: The Institute for Intercultural Studies and Research ("The Institute" or "INESIN") and Melel Xojobal. Both agencies are Global Missions Partners, supported in large part by our contributions to Our Church's Wider Mission and One Great Hour of Sharing.

The Institute was actually formed by UCC clergy, working in the 1990s with Bishop Samuel Ruiz to address the systemic oppression of the Mayan communities that resulted in some violent uprising. They addressed the violence of the clash between the grassroots rebellion groups and a "fifth column" of the Mexican government through peaceful education and community development. Their work changed the landscape of the culture in Chiapas, and has brought about a more peaceful exchange of ideas. Their work to educate and empower the people continues to be an important force for good in Chiapas.

Melel Xojobal works directly with the children of San Cristobal, Chiapas. They provide preschool, daycare, education and advocacy initiatives for the many children of San Cristobal, many of whom are forced to work on the street selling textiles made by their communities. Melel Xojobal ("true light" in the native Tzotzil language) is a light of hope for children who need direction.

In 2019, the congregation of CUCC voted to donate our "Special Mission Project" funds (\$5750) to these two Global Missions Partners (\$3000 to INESIN and \$2750 to Melel). These donations will help their institutional development so their important programming can continue.

We will be travelling to San Cristobal, Chiapas again this summer- June 30-July 7. If you are interested in finding out more about the trip, contact Pastor Rick.

MUSIC & WORSHIP MINISTRY TEAM

PURPOSE: To assist and support the pastor's and the music director's coordination of praise, thanksgiving, confession, and faith response that connects worshippers to God.

The 2019 calendar year has been an inspiring period of creativity, transition, and development for the Worship and Music Ministry Team. After many years of valued leadership of the Worship and Music Ministry Team, Melba Shaffer completed her service as ministry team chair at the end of 2018. Her service and attention to detail was greatly appreciated, and we continue to appreciate her presence and participation with the Worship and Music Ministry Team throughout 2019, and in to the future.

As Chair of the Worship and Music Ministry Team in 2019, my individual goals for ministry service included: fully learning and appreciating the variety of tasks and responsibilities shepherded by the Worship and Music Ministry Team, maximizing engagement of a variety of team members in the preparation of communion, and consistent documentation of meeting agendas and minutes. In brief summary, the members of the Worship and Music Ministry Team welcomed me warmly and provided unlimited and unapologetic guidance to me; thank you! We have had a variety of team members step up and volunteer to assist with communion preparation; the adage is true, teamwork makes any task more manageable. Finally, a written agenda was provided for approximately 80% of our meetings and formal meeting minutes were documented for approximately 70% of our meetings. Effective documentation can be an important tool to facilitate progress our goals and initiatives, so continued improvement and consistency of documentation will be a goal for 2020.

The Worship and Music Ministry Team began two broad initiatives this year, with two associated subgroups that met intermittently (i.e., in addition to regularly scheduled Worship and Music Ministry Team meetings). The Banner/Visual subgroup focused on reviewing and auditing visual aspects of worship, the sanctuary, and other special church events. This subgroup facilitated, in coordination with Pastor Rick, special visual displays for Pentecost, the 50th celebration, and confirmation Sunday (i.e., as just a few notable examples). A 2020 goal for the Worship and Music Ministry Team, and the Banner/Visual subgroup, is to audit and review all of our banners and 1.) replace banners that are worn or faded, and 2.) purchase, design, or create additional banners that are otherwise needed.

The Lights, Sound, and Technology subgroup met a few times this summer and fall; a number of worship needs in the sanctuary were identified (i.e., including, but not limited to: more effective chancel lighting, speakers and speaker placement, sound board, worship computer and related effective worship software, and hardware/software for live-streaming of all, or parts of, weekly worship services). Paragon360 was engaged for consultation; two Paragon360 members met with Worship and Music Ministry Team members and other interested congregation members. Some preliminary recommendations for technology were made, but we are still awaiting more complete and formal design recommendations to fully inform sensible and effective use of 50 FOR 50 campaign funds (and other designated funds as appropriate) in 2020 to enhance worship experience. Moving the choir to the center chancel area for performances was one Paragon360 recommendation that we have already implemented in 2019.

Per guidance from Pastor Rick, the Worship and Music Ministry Team created, reviewed, and submitted a description of ministry team roles and responsibilities. The draft was submitted to, and accepted by, the Church Council. We also reviewed and updated our Vision Team goals. The bell and vocal choirs continue efforts and activities to engage the full variety of church members, with a variety of worship celebrations and experiences (e.g., non-traditional music ensembles, special skills ensembles, incorporation of dance, rainbow bells, etc.). A youth choir was initiated and performed a couple of times at the end of 2019. Finally, Pastor Rick continues to work with worship personnel to optimize the worship experience (e.g., consideration of number and placement of hymns, style of communion celebration, lighting levels for special worship services).

The Worship and Music Ministry Team feels momentum as we move in to 2020, and we are excited for the continued growth in our spirited worship celebrations!

PASTOR'S REPORT

Are we working towards maintenance or transformation?

Included in this Annual Report Booklet are statistics from the United Church of Christ Center for Analytics, Research and Data. Reading through those statistics can have a bit of a sobering effect. Those who understand the sociological workings of the church may be able to see in those numbers a perception that many churches in our denomination are more interested in maintenance than they are in transformation.

There is certainly a place for maintenance in a body of faithful Christians. Many Christians, facing the often-harsh realities of the world, turn to the church as a place of comfort and assurance. Maintaining the way things have been may bring a security that can anchor them in the midst of challenges life throws their way. For churches that are maintenance minded, that is perhaps the model that works best for them.

But a maintenance mentality as the focus for a community of faith can be detrimental. Maintenance mentalities focus on the communal memory of how things used to be in a perceived golden era of the church; and strive for a return to that state of being. The problem with that mentality is that the communal memory of how things used to be is a false memory. That communal memory is not reflective of reality, how things truly were, or comprehensive enough to include the anguish of those who were marginalized by exclusion in that era. We can never return to the era that exists in a maintenance mentality, because that era truly never existed.

There are other churches in our denomination, Columbia United Church of Christ among them, that are interested in transformation. These are the churches that are thriving, because they are not just worried about maintaining the world as it (never) was; they are interested in transforming the world into the world it can be. They are the churches that ask "what if?" and strive to investigate the possibilities. CUCC is actively pursuing transformation on many fronts; and that is what is causing the excitement and energy one feels each time they step in our doors. What if God's world can be transformed into a world more reflective of God's nature? What if we can be part of that transformation?

"Then I saw a new heaven and a new earth; for the first heaven and the first earth has passed away and the sea was no more. And I saw the holy city, the new Jerusalem, coming down out of heaven from God, prepared as a bride adorned for her husband. And I heard a loud voice from the throne saying, "See, the home of God is among mortals. God will dwell with them. They will be God's people, and God will be with them. God will wipe every tear from their eyes. I saw no Temple in the city, for its temple is the Lord God the almighty and the Lamb. And the city has no need of sun or moon to shine on it, for the Glory of God is its light, and its lamp is the Lamb. The nations will walk by its light, and the kings of the earth will bring their glory into it." Revelation 21:1-4.22-24

The Book of Revelation has been twisted by Fundamentalist Christians into a book of fear, falsely claiming that it contains predictions about the "end times." This is not so, and was not the way this book was written or how it was read for over 1800 years. For most of the existence of the church, we understood that the Book of Revelation is a book of hope. That hope is expressed throughout the 22 chapters of Revelation, but culminates in the Vision articulated in chapter 21. This chapter conceptualizes what is possible when God's children choose transformation over maintenance. It articulates a vision of how the world could be if we would just choose the Wisdom Jesus shared instead of the fears our culture inflicts upon us. By sharing Jesus' Wisdom and embodying it in our lives, we can be harbingers of the New Jerusalem; not a geographical place, but in our identity as centers of faith, the household of God. The Jerusalem articulated in Revelation 22 is a way of living, a way of being; the way the world can be transformed.

This same call to transformation is seen throughout the Bible from the call of Abram (Genesis 12) to Jacob's wrestling match with God at Peniel (Genesis 32) to Moses' call (Exodus 3) and the many acts of transformation in the Book of Acts (Acts 8, Phillip and the Ethiopian Eunuch; Acts 9, the conversion of Saul; Acts 10-11, Peter and Cornelius; just to name a few). In none of these instances does God call God's followers to "stay the way you are and maintain the institution as it is." God calls them to transformation; of themselves and of the world.

I just finished reading a book by Transgender Theologian Austen Hartke titled, "Transforming: The Bible and the Lives of Transgender Christians." If you have not read it yet, I encourage you to do so. It was written by a transgender man who has experienced trauma in the church because of the way God created him. It details his journey from being a faithful Christian and being victimized by the church, to finding a new faith community and eventually going to seminary. A graduate of Luther Seminary (ELCA) in St. Paul, Minnesota, Hartke holds a Master's Degree in Old Testament/Hebrew Bible Studies. In his book, after discussing his transformation in the early chapters, he dissects many of the Biblical stories we have heard for years and analyzes them through the lens of a transgender Christian. One of the stories he discusses is this one:

"Which one of you, having a hundred sheep and losing one of them, does not leave the ninety-nine in the wilderness and go after the one that is lost until he finds it? When he has found it, he lays it on his shoulders and rejoices. And when he comes home, he calls together his friends and neighbors, saying to them, 'Rejoice with me, for I have found my sheep that was lost.'" (Luke 15:4-6)

Hartke comments, "Many of us probably heard this story for the first time as children. It is a Sunday School favorite. But what if we imagined this story a different way? What if the lost sheep did not wander away from the safety and goodness of the shepherd? What if it was just trying to escape the cruelty of the flock? Sheep will occasionally pick out a flock member who does not fit in and they will chase the sheep away. (Chickens do this, too -PR) There are times when I think Christians need to see ourselves more in the ninety-nine sheep who stayed put, and ask ourselves if we may have been part of the reason that the lost sheep got lost in the first place."

He continues, "What is at stake for Jesus in this situation isn't just that one single lost sheep, and it is not just the ninety-nine sheep back home. It is the integrity of the flock as a whole. Saving just the main group or just the individual would not do any good...when Jesus goes after that lost sheep, he is telling the flock; he is telling us; that we are not complete without each other."

In essence, Hartke tells us that the lesson of the parable of the lost sheep is one of transformation; not just saving the lost sheep or even prioritizing the lost over the other ninetynine sheep, but transforming the flock as a whole. As Jesus' flock, we must always be open to being a flock transformed; and we are called to work at transforming the rest of God's flock.

Here at CUCC, we are practicing transformation; of ourselves, and of the world. We are a church with a transformation mentality, and it is seen in everything we do. In 2019 we took a bold step towards transforming God's world by articulating Jesus' Inclusive Love when we overwhelmingly adopted our "Love Contract;" the CUCC Open and Affirming/ Inclusion Covenant. By adopting this Covenant, we have boldly proclaimed that we will faithfully embody God's love in this community. We will be a beacon of hope for those who have been victimized and marginalized by others. We will not only seek lost sheep, but we will also seek transformation for the flock. By adopting this covenant, we have boldly proclaimed that we are not about simply maintenance; we are also about transformation.

Since adopting this "Love Contract" we have suffered some heartache; but that is the price for being prophetic. Abram, Moses and the disciples all suffered heartache as well to maintain the integrity of God's message of radical, extravagant, inclusive love and cultural transformation; and we follow a leader who was crucified for maintaining his integrity. As today's prophets and disciples, we can expect no less as we also work for cultural transformation.

Over the past few years, I have set a few pastoral goals, all focused on transformation. Some of them I am still striving towards, others I am working to develop further. Among those goals are:

- Continue to develop pastoral connections with congregation members
- Continue to work with youth and young adults, empowering their ministry
- Continue to work with worship leaders to develop transformative worship
- Continue to develop staff relationships and professional skills
- Continue to develop our mission work with Chiapas, Mexico and Global Ministries
- Continue to develop and support our Inclusion efforts
- Develop a team to visit our Homebound Members
- Develop Fellowship/Family groups, including a group for our Seniors

We have also completed a few goals in the past year:

- Our review of CUCC Constitution and By-Laws; we will be presenting revised documents to the congregation in early Spring
- Definition of our Designated Funds; we will begin developing them further
- Descriptive documents for each Ministry Team
- Development of our Heritage Team

Special thanks this year goes to our Heritage Team. The folks on this team helped pull together our 50th anniversary celebration, as we remembered and reflected on our identity over the past 50 years. Listening to the stories told by Fred, Jerry, Virginia, Jolene, Melba, Ed, Sue, Donna and others about how this church has been transformative over the years helped affirm the course we are headed on for the future; and it was a great party!

Thank you to those who donated to the "50 for 50" campaign. We may not be focused solely on maintenance, but maintenance does have to be done! This overwhelmingly successful campaign will help us maintain our ministry setting for many more years, in honor of our heritage.

Many thanks go to our incredible CUCC staff: April, Erika, Kristin, Amy, Raj, Lloyd, and our LODO teachers and assistants. They make ministry happen in wonderful ways here at CUCC "behind the scenes." I am blessed to see this staff in action every day; and the things they do are amazing and transformative in themselves. Most of CUCC does not really comprehend the work that happens "behind the scenes;" but much of our ministry happens because of the foundation set by this group of hard working, faithful people.

Thank you also to the CUCC Church Council for their work; especially retiring Moderator John Graves. The work we do together as a Church Council is important, but it is never about simply perpetuating an institution. As its core, everything we do is about transformation. God's call to ministry is very evident in these faithful servants; and we have a lot of fun doing it. It is a joy to work with these faithful servants.

As we look forward to an exciting new decade, I encourage you to not just be about maintenance (although maintenance is important, too), but also about transformation. Look at how you and the world can be transformed. May we all work together to make God's Kingdom a reality in this place!

At the November 10, 2019 Congregational Budget meeting, the preceding budget was approved unanimously by the Congregation. Listed below are informational notes, corresponding with the subscript notations in the budget.

2020 BUDGET EXPLANTORY NOTES

- 1. Budgeted increase in Joyful Giving for 2020 is 5.29% over 2019 giving to support the 2020 budget expenses
- 2. The 2019 budget had amounts for Camp Scholarship Fundraising and Camp Scholarship expense as the Nurture and Education Ministry Team wanted visibility to the amount of camp scholarships funded. This was newly added in 2019. Prior to that, all camp scholarship funding passed through the Nurture and Education Designated (formerly "Historic") fund. After discussion, it was decided that, for clarity in bookkeeping, to return to this method.
- 3. We implemented Kindrid to facilitate online giving in 2019. At the time the 2019 budget was approved, Council had not decided what product would be used, or a cost estimate of the expenses. The 2019 financial statement report Kindrid fees under Payroll Expenses/Bank Service Fees. After discussion, it was decided to separate them in 2020.
- 4. In an effort towards continuing staff development, an amount has been budgeted to accommodate staff continuing education.
- 5. Vacation Bible School had a large number of participants this year, and it is anticipated this trend will continue, necessitating greater expenses.
- 6. Greater increases in Confirmation activities and a proposed educational trip necessitated greater expenses in this category
- 7. Increased Fellowship Activities have necessitated an increase in this category
- 8. We are increasing our support for Our Church's Wider Mission by 3.17% over 2019 to reflect our identity as a United Church of Christ congregation
- 9. Increase to Local Missions includes a budgeted increase to Columbia Older Adult Ministries and a new initiative to become a Partnership Friend with Alpha Hart Lewis Elementary School
- 10. We budgeted an overall increase in staff salaries by 3%. Specific increases will be communicated to each staff member by their supervisor.
