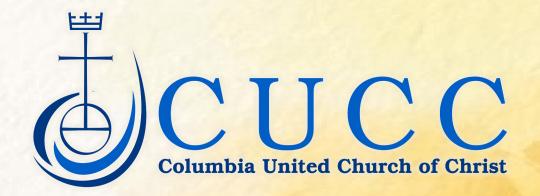

# INTRODUCTION

Three years ago, in our 2019 Annual Report, collated in January of 2020, I asked you that question. In the context of that question, I anticipated us having a stellar 2020 if we all united behind a common vision.

Then, the next month, the world fell apart. COVID ravaged our society, and by March 15, 2020, our church was shut down and would remain shut down for almost three months. We adapted to new ways of being and new ways of worshipping God. We found new ways to be in communion with each other through drive by parades, drive thru pickups at church, and gifts (Mother's Day and Christmas) mailed to the homes of every congregation member. We became a community in new ways.

Now, three years later, in our post-pandemic world, we are still reeling from the ravages of COVID. The leadership of CUCC is trying to figure out how to rebuild a church that, like every other church in this day and age, has been compromised by the cultural isolationism inflicted upon us by the virus. But like the Phoenix, or the King Protea Plant (see my report for details on page 42), we are emerging from the ashes of COVID and rebuilding a ministry that is more focused on God's will than ever before. I am convinced that the church that is emerging from the ashes of COVID will be more faithful than the one that preceded it, at CUCC and across the world.

The report you hold in your hands is evidence of the church's resurrection. The reports contained herein detail the many ways the ministries of CUCC are rebounding and rebuilding as we move into a post-pandemic world. I hope you will take the time to read through this report and celebrate all the new and exciting ministries that are happening at Columbia United Church of Christ!

# **PURPOSE:**

To provide leadership for the Council and Congregation, working to ensure that the Constitution and Bylaws are followed, that the Mission Statement is lived out, and that components of the Strategic Plan are executed; to foster a loving, Christian environment consistent with our stated Core Values.

# Highlights:

One of the biggest markers of the 2022 calendar year at Columbia United Church of Christ was our experience with a pastoral sabbatical. This was, of course, an opportunity for reflection and rest for Pastor Rick at the culmination of five years as Pastor of CUCC and in preparation for his continued ministry with our congregation. It also served a vital purpose for the rest of us. We, as members, expanded our understanding of our responsibilities to our church, and the Church Council increased efforts to empower ministry teams and individuals in carrying out the vision of CUCC.

Our ministry activities and initiatives over the past year have been vast. Some of the highlights include expansion of adult education opportunities, as well as book studies and informative offerings to increase awareness of diverse cultures. A health and wellness ministry for congregation members was also initiated this year. In 2022, we continued to incorporate a wide variety of music into our worship services, enriched by guest musicians and choir section leaders, and we upheld many fellowship traditions that carry great meaning in our congregation. We also reached out beyond our circle of fellowship by collaborating with organizations like Loaves and Fishes, Mobility Worldwide, the Food Bank, and the Voluntary Action Center, sharing our time and gifts with those in need. Our LODO preschool continued to provide a high-quality early childhood education opportunity for families in the community, and staff was expanded to include a Curriculum Mentor. While carrying out our various ministries, we maintained and updated necessary components of our church building and parking lot, and we worked continuously to plan and manage finances to facilitate new and continued ministries.

At the close of 2022, we reflect on our past experiences to determine our path for the coming years. As a congregation founded in 1923, we begin to prepare for our centennial by *Celebrating our Past* and *Embracing our Future*. Much has changed over the past year and even more over the past one hundred, but throughout the history of our church, we continue to be followers of Christ working together and caring for each other.

# SECRETARY'S REPORT – ANNUAL MEETING MINUTES \_\_\_\_

Annual Meeting Minutes: May 15, 2022

Moderator Kristy Odneal called the meeting to order at 12:09 p.m. in the Fellowship Hall. We had 71 in attendance including 8 who joined virtually. Pastor Rick opened the meeting with a prayer.

Carol Duermeyer made a motion to approve the minutes from the 5/16/21 Congregational meeting with a second by Mahree Skala.

Kurt Heine made a motion to approve the minutes from the 11/7/21 Budget meeting with a second from Carol Duermeyer.

# FINANCIAL REPORTS:

Sue Ann Schaefer reported that Joyful Giving exceeded our budget for 2021. She said it would be nice if the giving could be spread out more evenly during the year, rather than waiting till December to see if we are going to meet the budget. Giving Tuesday was a success. VAC received 5 %, City of Refuge 5% and the rest went to Joyful Giving. As of right now, Joyful Giving is behind \$22,000.

Sue Ann also explained how 3 of our Designated Funds were moved to United Church Funds to earn interest.

Sue Ann stated that \$12,000 has been budgeted for the Sabbatical pastor, but that we might only use \$9,000.

# **NEW BUSINESS:**

Kristy Odneal stated that the Church Council is making a recommendation and motion to the congregation to amend the budget for 2022. The amount of \$2,700 would be used to hire Section Leaders for the choir for the Fall semester. Motion passed by show of hands.

Kristy Odneal mentioned that the 100<sup>th</sup> Anniversary is approaching, and if you would be interested in being on the committee, please let us know.

Pastor Rick encouraged us to read the Friday emails and the monthly Communicator to know what is going on in the church. Invite friends to church also.

# MODERATOR'S REPORT:

Kristy Odneal told how we had to close the doors in March 2020 for COVID, but we continued to have worship services online.

# **VICE MODERATOR'S REPORT:**

Kurt Heine talked about the 5 year Strategic Plan and how the Ministry teams have already accomplished some of their goals.

# MINISTRY TEAM REPORTS:

**Building & Grounds:** Question was asked when appliances were going to get fixed/replaced. Downtown Appliance has loaned us two refrigerators, and the upstairs kitchenette dishwasher is being assessed on Tuesday, May 17.

**Fellowship & Hospitality:** Lena Muench mentioned that two fellowship events have been canceled because of lack of participation.

Finance & Stewardship: Helen Schultz asked about the giving envelopes. We will start a new system in January 2023 with a company who will mail envelopes once a month to giving families. If a family moves, they will provide us with a forwarding address.

**LODO:** Graduation is this coming week. The new signs are up, and this fall, is LODO's 20th Anniversary.

Membership & Care: The Cares Ministry program is up and going. Any visitors are welcome to talk to Pastor Rick about joining CUCC.

Outreach: Mark Duncan thanked everyone for donations to the Refugee families.

Worship & Music: Mike Pierson thanked those who were involved with the music of the church: Amy Crousore, Brandon Brown, and Pastor Rick. Mike also said that the lighting will be installed in the chancel area the end of June.

Youth Fellowship: Lena Muench encouraged youth to participate.

**SABBATICAL TEAM REPORT**: Judi Privitt announced that Rev. Dale Parson will be the Sabbatical pastor while Pastor Rick is gone.

**VIRTUAL VOTING POLICY:** Bryan Crousore stated that he liked the policy but that he thought it should be in the church by-laws. This will be looked into.

Lorry Dreier made a motion to adjourn with a second by Mike Pierson. Meeting adjourned at 12:58 p.m.

# OVERVIEW OF 2022 FINANCIALS – TREASURER

**PURPOSE:** To assist the church council by maintaining financial records and providing monthly management accounts to assist in financial decision making.

# 2022 Financial Highlights:

- Joyful Giving total of \$327,745 and our budgeted goal was \$365,708, leaving a *shortfall of \$37,963* under our Joyful Giving goal. We needed to withdraw \$20,000 from the main investment account to help cover our Joyful Giving deficit.
- Giving Tuesday was a success again because of the generosity of the membership. The total giving amount was \$26,255. The funds were added to our Joyful Giving total.
- The Designated Funds invested with United Church Funds reflected the market conditions and ended the year with a net unrealized loss. Detailed information on these funds is included in a separate Designated Funds report.

Building Fund – 3% of Joyful Giving has been transferred each quarter to the United Church Funds Building fund. \$10,209 represents the amount transferred for the first three quarters of 2022. The 4<sup>th</sup> quarter amount will be transferred in January. Three of the HVAC units and the parking lot project were funded by the Building Fund at United Church Funds. The total amount withdrawn from the building fund to accomplish these projects was \$41,984.

Scholarship Fund - Five college scholarships in the amount of \$2,000 each were awarded to Carissa Graves, Lindsey Oberle, Brandon Brown, Kaden Lucas, and Hayley Dennis. The amount was withdrawn from the Scholarship Fund at United Church Funds.

The 2023 budget was approved at the November congregation meeting.

As treasurer I am humbled by the dedication and generosity of our members. Because of this commitment to our church, we have been able to carry out many local and international service to others. I want to thank the Finance and Stewardship Committee and the Church Council for their guidance and input. I wanted to give a special thank you to Rajini for her commitment to her duties. I couldn't do this without her.

# RECORDING TREASURER

Purpose: To receive, record, and deposit all monetary contributions.

# Activities/Highlights:

Joyful Giving for 2022 was \$327,745, which was \$24,173 less than we received in Joyful Giving for 2021. It was also \$37,963 less than the 2022 budget for Joyful Giving amount of \$365,708. The 2023 budgeted Joyful Giving is \$384,908.00 which is a 5.25% increase over the previously budgeted amount. We believe that the 2023 Joyful Giving goal is attainable.

One of the challenges of church finance is that 23% of our annual Joyful Giving income is remitted to the church in December. In December 2022, we received \$78,133.42 in Joyful Giving and Giving Tuesday. In December 2021, it was \$84,222.00. In December 2020, it was \$95,563.00 that month alone. It would be helpful to spread some of that out during the course of the year. Stock donations and IRA distributions are welcome all year long. We hope that 2023 provides a more steady income all year.

# DESIGNATED FUNDS

In February 2022, the Church Council approved a recommendation from the Finance & Stewardship Ministry Team to invest more of our funds with United Church Funds (shown with asterisk). With the invasion of Ukraine, the downturn in the stock market hit about this same time. As a result, we lost significant amounts in our investments this year. As of January 1, 2023, our balances with UCF for all accounts totaled \$383,365. In 2022 these accounts decreased in value by \$88,392 in realized and unrealized losses.

We also added \$10,209 in "new money" to our Building Fund, which was 3% of our Joyful Giving for Q4 of 2021 and Q1, Q2, and Q3 of 2022. (2022 Q4 3% will be added in January, 2023.) We withdrew \$41,984 from our Building Fund to pay for building upgrades (3 new HVAC units and parking lot project). We withdrew \$10,000 from our Scholarship Fund in 2022 to fund five awarded Scholarships to college students Carissa Graves, Lindsey Oberle, Brandon Brown, Kaden Lucas, and Hayley Dennis. We also withdrew \$20,000 from our main investment account to cover our 2022 Joyful Giving shortfall.

Despite the downturn in the stock market this year, the move to UCF was very beneficial to the financial picture of our congregation and will help us move forward with ministry

projects in the future. We anticipate future growth in all of these funds. All of these funds are open to estate donations, stock donations, ongoing contributions, or one-time donations. If you would like to set up a recurring gift or an estate donation to one of these, contact me, and we will work together to set that up. Thank you!

# FINANCE & STEWARDSHIP MINISTRY TEAM

**PURPOSE:** This Ministry Team is responsible for oversight of CUCC's finances. These duties include oversight of the church's investments and advising the congregation and Church Council of their status. We compile and prepare the church's annual budget and promote congregational support of the budget. The team is also responsible for the education and implementation of stewardship principles to serve our greater mission through our combined time, talent, and treasures.

Members of this ministry team include: Keith Birkes, Sue Ann Schaefer, Brent Marks, Paula Wilson, Doug Privitt, Charley Marcks, Christine Staelens, Barry Kirchhoff, George Zimny, and Dominick Lee, with special thanks to Pastor Rick Oberle.

### This Year's Activities:

- Time and Talent sheets were distributed, reviewed, and members were assigned to the ministry teams and activities as requested.
- Pledge cards were distributed, and responses were tallied.
- The Committee is informing the Congregation on a regular basis how we are doing with Joyful Giving.
- Five scholarship applications were approved for church members, and plans have been made to expand the number and dollar amount of scholarships based on earnings and contributions to the scholarship fund.
- The 2023 budget was prepared by Treasurer Sue Ann Schaefer, recommended by the Committee, approved by the Council, presented to the Congregation, and approved. The 2023 budget is \$392,330.
- A 5.2% increase in Joyful Giving was included in the 2023 budget.
- 3% of Joyful Giving received will continue to be transferred to the Building Fund to provide for important capital improvements in our 53-year-old church building.
- Our goal of \$25,000 for Giving Tuesday was reached and slightly exceeded. We received \$26,225. The Committee and the Congregation worked very hard to reach this goal.
- Joyful giving for 2022 was budgeted for \$365,708, but that goal was not met. We took in \$327,745 in Joyful Giving: \$37,963 below our goal and \$25,000 below last year.
- The Committee sponsored a stewardship potluck luncheon at which time our church finances were thoroughly discussed, and the importance of stewardship was emphasized.
- The church policy on gifts and how they are acknowledged was revised.
- The Committee is developing a plan to raise the necessary funds to renovate our sanctuary. That plan will be rolled-out to the Congregation in January of 2023.
- Various testimonials about our church have been produced and proved through social media with the expert assistance of Dominick Lee.
- The Committee is developing strategies to implement the following specific strategic goals:
  - 1. Sustain financial stewardship efforts.
  - 2. Develop a long-term maintenance and renovation plan for facilities.
  - 3. Strive for an annual 5% increase in joyful giving.
  - 4. Set donation goals for designated funds.
  - 5. Continue to modify and improve financial policies and procedures.

# MEMBERSHIP & CARE MINISTRY TEAM

**PURPOSE:** Our purpose is to enable, establish, and maintain programs to care for members of the Congregation and meet the needs of their membership. We continue to evolve our programs to welcome, support, and integrate our guests and members; keep the membership records of the church current; and implement marketing techniques.

Members of this team include: Sue Beckman, Carol Duermeyer, Helen Schultz, Audrey Lasley, Anne Heine, Jessica Lucas, Jolene Kirchoff, Judi Privitt, Susan Dunham, Lea Marienfeld, and ongoing support, ideas and involvement from Pastor Rick.

The Membership & Care Team meets once a month. We've welcomed **ten** new members into the church. We also worked hard outside of planned meetings to assure new members are welcomed, cards are delivered, life circumstances are recognized, and our congregational members are cared for.

This year our CUCC CARES (Compassionate Actions Reward Everyone) Ministries continued our task-oriented, hands-on ministries that provide care for our congregation members in times of celebration and need. They include Note Writers/Cards, Handy Helpers, Visits to Church Members, Bereavement, Flowers, Meals, Prayer Shawls, Transportation, and Prayer Ministries. After recruiting members, these ministries have become very active in sending cards, planning visits, making hand-made items, providing meal trains, helping with funerals, providing rides, and praying for our members. We continued these ministries during Pastor Rick's Sabbatical. We added an additional ministry, the Health Care Ministry, under the leadership of Anne Heine. This group has the goal to assist members in meeting their health care needs through education, support, transportation, and advocacy as needed.

This year we continued to assure each visitor and member was greeted with purpose and intention. When a visitor is recognized, they are greeted and welcomed with a bag filled with info about our church and how they can get involved. We also had a "Bring a Friend" Sunday in April, which encouraged members to invite someone with them to church either physically or to worship on-line; we had 22 visitors at our April event. The picnic at the shelter had a lovely turn out and delicious food. The VBS preview included crafts before the service and a bouncy slide during the picnic. On that day, we also honored our graduates (8th, high school, and college) with cake during Fellowship time and recognition during the service.

**VACATION BIBLE SCHOOL:** VBS was held on August 1st through 3rd. Its theme was "Food Truck Party," and it was organized and run by Lena Muench and Gina Pierson. There was high attendance and many volunteers.

**SAFE CHURCH TRAINING:** The annual Healthy Relationships Training was held on July 24th and August 28th. This course was taught by Linda Neale.

**NURSERY:** Over the summer, nursery supervision was performed by members of the committee. In October, our new nursery supervisor, Summer Lyons, was hired. She is a sophomore at Mizzou studying elementary education, human development, and family science.

**RALLY DAY:** Rally Day was held on September 11th. The theme was "Bounce Back to Church" and was well attended. Sunday School classes began again for all ages. The youth enjoyed a bouncy house, and all enjoyed a fish fry after church!

ADULT EDUCATION OPPORTUNITIES: Adult Bible Study in the fall was taught on rotation by Phillip Neale, Barry Kirchhoff, Shelly Adams (Seminary Student), and Rev. Dale Parson (Sabbatical Pastor). There were three Contemporary Issues classes scheduled for the fall, although one had to be canceled due to health-related circumstances for the teacher. In September, Rev. **COOKIES BY THE POUND:** This fundraiser was held on December 11th and was a big success: raising over \$500 for our Designated Fund and completely selling out of cookies. The event was hosted by Lydia Whitace, Gina Pierson, and Lori Dreier.

CHRISTMAS PROGRAM: The Children's Christmas Program was held on December 18. Program rehearsals began November 27 during Sunday School. The program was run and directed by Linda Neale with help from Paula Wilson on costumes. The program was titled "A Christmas Window" and featured a story of discovering the real meaning of Christmas. All those involved did a wonderful job!

**SPIRIT SUNDAYS:** An initiative called "Spirit Sundays" was started this fall in an effort to increase youth Sunday school attendance. The Spirit Sunday will happen roughly once a month and be a smaller version of "Rally Day" themed around a holiday or important church event. Our first Spirit Sunday was Halloween weekend and incorporated the Book

# OUTREACH & ADVOCACY MINISTRY TEAM

**PURPOSE**: To coordinate and encourage participation in local outreach activities; promote organizations included in the annual Outreach budget; promote support for Our Church's Wider Mission and the special offerings of the United Church of Christ; identify non-partisan issues for which advocacy may be appropriate.

After dealing with early year variants of COVID-19, some normalcy continued to return in 2022 as the vaccines allowed more freedom of movement and gatherings. We were able to sustain our in-person outreach team projects. Many CUCC members and friends contributed their time, talents, and treasure in 2022. The Russian war on Ukraine impacted fuel and food cost, along with the economy picking up, resulting in 40-year high inflation impacting those who were already challenged to meet living costs. The activities listed below are a sample of the congregation's Outreach and Advocacy efforts.

# Special Offerings and Contributions

CUCC was again a "Five for Five" congregation, supporting all 5 UCC campaigns—Our Church's Wider Mission, One Great Hour of Sharing, Strengthen the Church, Neighbors in Need, and the Christmas Fund (Veterans of the Cross). We supported the Food Bank of Central and NE Missouri (5th Sunday offerings) as they experienced a steep increase in demand with people unable to afford the inflation in food prices. In addition, we collected special offerings for Church World Service Tools and Blankets Sunday; the CROP Walk (CUCC contributions were 2<sup>nd</sup> in all local churches); supported the Festival of Sharing; and the Christmas Eve offering went to Camp MO-Val that reopens in 2023.

# **Budgeted Support for Service Agencies**

Through the congregation's generous support, \$25,550 from the general fund was disbursed to 12 local service agencies and 10 state, national, and international organizations to assist their work in feeding the hungry, ministering to refugees, serving disaster victims, housing the homeless, and providing spiritual support for people in their times of need. The special mission project provided \$1,250 to the Food Bank of Central and NE Missouri and \$1,250 to the Voluntary Action Center to assist community members facing crisis from inflationary costs.

# Gathering Supplies and Gifts

CUCC donated generously to several collection drives. For our Partner in Education school, Alpha Hart Lewis Elementary, we contributed school supplies and provided snacks for Parent-Teacher conferences; we also dispensed Christmas gifts and food for 40 local people via the Voluntary Action Center Christmas Drive and money for additional family needs.

# Faithful Service

The Food Bank volunteer opportunity presented, and CUCC had groups each month. Many CUCC groups and individuals helped Audrey Lasley serve meals to homeless and low-income people every third Monday at Loaves and Fishes (Wilkes Blvd. Methodist Church). Twenty-seven volunteers picked up 50 bags of trash near the church during Clean-Up Columbia Day in April. The Alpha Hart Lewis partnership in education has been held up as a model for faith and community partners. Thanks to Llona Weiss, the faithful team of volunteers, and our church's generous contributions to the staff and families.

What is Our Church's Wider Mission? It is *not* an Outreach program; it *is* about identity. Our Church's Wider Mission (OCWM) is who we are as Christians, acting out love in God's World. OCWM is who we are as God's Children!

Where does the money go? When we remit our OCWM contributions each month, 80% of the funds stay here in the Missouri Mid-South Conference to undergird and support Camps MoVal and Shannondale, to support the ministries of the Conference, to support churches in need, to provide pastoral assistance for churches in the search process, to provide revitalization resources for churches seeking new growth and vitality.

Twenty percent of the funds we send are remitted to the National Setting of the United Church of Christ where they are used to fund our missionary work overseas (such as the work being done in Chiapas): to provide resources for clergy and churches seeking growth and revitalization, to help churches who are struggling, to advocate for those who are disenfranchised and in need of God's healing love, to enable youth programming throughout the denomination, to change lives and transform the world into an image more reflective of God's passion for shalom.

Columbia United Church of Christ has committed to supporting God's work through our increased support of Our Church's Wider Mission each year. This is not outreach, this is who we are; God's Children making a difference in God's World.

Our budgeted amount for 2023 remains the same as last year, \$15,000. With increases the

last five years, we felt it prudent to remain steady a year or two to allow Joyful Giving to catch up. We continue to be a strong donor in the Conference and intend to maintain our commitment to our identity as Christians by supporting OCWM in this way.

# CHIAPAS MISSION REPORT

The year 2018 was the beginning of the relationship between Columbia United Church of Christ and our Global Mission Partners in Chiapas. After a year of studying about the culture and climate of Chiapas, in October 2018, seven CUCC members (and four from other churches) travelled to Chiapas for our first ever Mission Immersion Experience. It was quite an exciting time as we learned about the people of Chiapas and the context in which they live. We contributed to finishing the Bishop Samuel Ruiz Multipurpose Facility, the building which has been constructed in large part by members of the Missouri Mid-South Conference of the United Church of Christ. Our hearts were changed forever by our experiences in Chiapas.

There are two agencies we work with directly: The Institute for Intercultural Studies and Research ("The Institute" or "INESIN") and Melel Xojobal. Both agencies are Global Missions Partners, supported by Our Church's Wider Mission and One Great Hour of Sharing.

The Institute was formed by UCC clergy working in the 1990s with Bishop Samuel Ruiz to address the systemic oppression of the Mayan communities. Their work has changed the landscape of the culture in Chiapas and has brought about a peaceful exchange of ideas. Their work to educate and empower the people continues to be an important force for good in Chiapas. They have almost two dozen support and education programs they manage annually.

Melel Xojobal works directly with the children of San Cristobal. They provide preschool, daycare, education, and advocacy initiatives for the many children of San Cristobal, many of whom are forced to work on the street selling textiles made by their communities. Melel Xojobal ("true light" in the native Tzotzil language) is a light of hope for children who need direction.

I had the opportunity to work with both of these agencies the month I lived in Chiapas during my sabbatical, and I was very impressed with the work they are doing and the changes they are bringing to these oppressed communities.

In our 2021 budget, for the first time, we included these agencies in our "Wider Missions" line item, giving each agency \$500. That support continued in 2022 and is in our 2023 budget, as well.



We had planned to take another trip there for a Mission Immersion Experience in 2022, but the pandemic sidelined that. But we have a trip scheduled for June 8-15, 2023! Mark Duncan and I have information packets if you are interested in going on the trip. We are limited to ten participants, so let me know if you want to go!

# WORSHIP & MUSIC MINISTRY TEAM

**PURPOSE:** To assist and support the Pastor and the Music Coordinator in their coordination of praise, thanksgiving, confession, and faith response that connects worshippers to God.

The Year of 2022 was a time of continual growth in music and worship at Columbia United Church of Christ. Throughout this year, we saw a growing number of people returning to church after the COVID 19 pandemic! The Chapel Ringers and Celebration Singers continued to grow in number and strength under the leadership of Brandon Brown. At Brandon's urging and with Council support, we added Soprano, Alto, and later, Tenor, section leaders as paid positions in the choir. This is a common practice at other churches in town which contributes stability and leadership for the choir. We continued reaching folks who were not able to join us in-person by way of our streamed services on YouTube. That continues to be an important link to the community (and all parts of the world) and a method of attracting potential future members.

To staff our needs in the technology booth, weekly volunteers/technicians continue to operate the sound and video equipment. Doug Privitt continues to do a great job of recruiting additional volunteers. We continue to train volunteers to operate the soundboard/sound system, as well as the live streaming software and hardware. A move to use of a PowerPoint-like software called "Faithlife Proclaim" was made in October. Proclaim offers the connection to an online Bible reference, a library of hymns and songs, incorporated announcement loops, etc. that makes it more applicable and useful in a church setting. It is a subscription service that is purchased through Worship and Music budgetary funds.

Brandon Brown continues his outstanding leadership of the Music program as Music Coordinator. The Chapel Ringers and Celebration Singers presented many fine, individual Sunday performances, along with a "Sermon in Song" December 11th filled with a variety of exciting and poignant songs, which included additional musicians from the community. Through Brandon's leadership, CUCC became a partner with the Columbia Civic Orchestra and Columbia Chorale in presenting Handel's "Messiah" in a sing-a-long format. CUCC was well represented in the chorus. Brandon was the featured bass soloist for the event that took place at First Baptist Church in December.

Installation of additional sanctuary lighting to brighten the chancel, song leader, and bell areas was completed by Doug Privitt and Mike Pierson in the summer of 2022. This greatly optimizes the picture quality of our live streaming cameras and also presents a stronger worship experiences to our in-person members.

The Banner Team of Jo Ellen Grace, Jolene Hackman, Connie Loveless, Lea Marienfeld, and Melba Shaffer met multiple times creating new banners, including *Feed My Sheep* and *Hosanna* and also refurbished several older ones.

Planning for the Sanctuary Renovation picked up pace as 2022 came to a close. Mike spent a lot of time meeting with Kenna Weber of Abundance Designs selecting carpet, wallpaper, paint, etc. He was then able to contact several different companies/vendors to procure quotes for the different services/products. A proposal was submitted to the Finance and Stewardship Team in December for their approval. They will be planning a fundraising campaign and presenting that information to Council in early 2023.

Pastor Rick continues to point out that our church is leading the way in Columbia in attracting new members, post-pandemic. This a testament to the power of not only the worship and music ministry at CUCC, as well as the loving, affirming, welcoming nature of all those who come through our doors! Our goal continues to provide powerful and meaningful worship experiences for all those who are present and at home.

# The Sabbatical Team began meeting semi-monthly on March 10, 2022 to:

- Develop Job description of Sabbatical pastor and curate a candidate.
- Coordinate the Supervision of CUCC staff.
- Plan for Emergency services (funerals, hospital visits, etc.).
- Coordinate Pastoral Care needs with Membership & Care, including visiting homebound members and members in Care Facilities.
- Work with Worship & Music Ministry Team, Sabbatical Pastor, and Music staff to coordinate special Sunday observances, worship themes, music, hymns, etc.
- Work with Nurture & Education to provide educational opportunities pertaining to Sabbatical for kids and adults and to provide leadership for Confirmation classes.
- Provide continuing information about the upcoming Sabbatical to the congregation through Sabbatical moments during worship, Communicator Articles, Friday emails, and bulletin inserts.
- Coordinate the completion of the weekly bulletins, power point presentations for worship, Friday emails, and monthly Communicators.
- Coordinate a Meet & Greet with Dale Parson on August 7, and a Good Bye Gathering for Dale on October 30, 2022. Coordinate a Welcome Back Reception for Pastor Rick on November 6, 2022.

## Sabbatical Team Activities:

- "While the Cat's Away, the Mice will Play" theme was created, Pastor Rick being the Cat and members of CUCC being the mice. Using a puzzle format (The Cheese Board), each puzzle piece (a piece of cheese) represented a job that needed a volunteer to complete it. A new puzzle was made for each month of August, September, and October, with the tasks for that month. A video explaining the theme and how to use the Cheese Board was created. A postcard was also sent to the congregation about "The Cheese Board." The response by volunteers was great, and the "pieces of cheese" were taken and completed by many congregants.
- Several congregants were asked what books they had read during Sabbatical, and these were shared by Power Point and during the Sabbatical Moment on Sundays.
- Cheez-It and Cheetos snacks were handed out on two Sundays to the "mice" (everyone in worship).
- Bryan Crousore offered "Spiritual Check Ups" for anyone who wanted to meet individually with him.
- The website to sign up for "Still Speaking Daily Devotional" from United Church of Christ was shared with everyone.
- Photos Pastor Rick sent from Chiapas were shown by PowerPoint on Sundays during October.

The Sabbatical Team will be decommissioned during worship on January 22, 2023.

# HERITAGE TEAM

One hundred years ago, a lot was happening in Columbia that would affect us as current members of Columbia United Church of Christ. Mizzou Professor H. H. Krusekopf attended an Evangelical Church back home. In 1921, Professor Krusekopf held prayer meetings, hosted speakers, and led worship services in his home, at the YMCA, and at the University of Missouri, where he was a professor in the soils department, School of Agriculture. Other leaders at this time were Ella Parmeier, Elsa Nagel, and Caroline Brautigam, who helped start our congregation and were involved well into the 1960s.

On January 23, 1923, our church was formally organized, calling themselves "The Evangelical Club." They were officially a mission of the Evangelical Synod of North America (one of the predecessor bodies of the UCC), providing a college ministry in Columbia on behalf of the Synod.

A motto of the Evangelical Club in 1925 stated their identity and purpose: "To strive after righteousness; to seek only the good in each other; to find the true meaning of life in service; and not to yield to less than the best that is in us."

The Evangelical Club grew and asked for a permanent pastor. The Evangelical Synod sent an Eden Seminary graduate, Ralph Abele, to serve as part-time pastor while doing graduate work at Mizzou. Meetings were held at the Bible College of Mizzou. He was in Columbia two years and got the group planning for the future.

Throughout the year, we will be celebrating our Heritage, while we embrace the great things that are to come. The motto of the year for us is, "Celebrating our Past, Embracing our Future." We will have several events all year long where we do just that. On January 22, we will kick off our Anniversary Year with a Pot-Luck meal and presentations from Walter Schroder and Melba Shaffer. Some of our other events planned are:

- Fastnacht February 21 (organized by Fellowship & Hospitality) with Anniversary focus
- Chili Cookoff March 19 (organized by Men's Fellowship) with focus on the 1940s
- LODO Anniversary Celebration April 16 (organized by LODO Ministry Team) with focus on the 20th anniversary of LODO and recognizing past teachers, directors, alumni
- Recognition of The Graduates Group and Student Clergy (date TBD- May or June)
- Come Gather Round a celebration of our Heritage September 30 with dinner and entertainment at the Farmer's Market Pavilion, and special celebrations in worship the next day, October 1, including a Choir Reunion with past choir directors participating!

The presence of energic LODO children in our building is refreshing and reminds us of the innocence and how impressionable children are. The building is also buzzing with their high energy. Director Erika and her staff continue to do an amazing job coordinating learning through fun activities for the children while serving the community through outreach. # STAFF REPORTS

## PASTOR'S REPORT\_\_\_\_\_

Luke 6:12: "Now during those days he went out to the mountain to pray; and he spent the night in prayer to God."

Luke 22:39-41: "He came out and went, as was his custom, to the Mount of Olives; and the disciples followed him. When he reached the place, he said to them, "Pray that you may not come into the time of trial." Then he withdrew from them about a stone's throw, knelt down, and prayed."

The Gospels are rich with instances of Jesus retreating from the day-to-day ministry of life to enter into a time of Sabbath. He retreated after being baptized to focus on God's call in his life, and to prepare himself for the temptations that were to come. He retreated into the wilderness to pray before selecting 12 to be his closest allies. He retreated and spent time in prayer before being crucified to prepare himself for the challenge that was to come. Sabbath time was critical to Jesus' ministry.

The past year of our church life has been dominated by the idea of Sabbath. For three months this fall, from August 1 - October 31, I was on Sabbatical from my duties as Pastor of Columbia United Church of Christ. The rationale of Clergy Sabbatical follows the Biblical model set by Jesus: spending time practicing Sabbath is integral to effective ministry. We followed the model for Sabbath that is advocated among church strengthening organizations: three months of Sabbatical after every five years of service. We utilized the strengths of the congregation to ensure a smooth Sabbatical experience. It was a joyful time for me, and for this congregation.

We began talking about Sabbatical in June 2021, a full 14 months before our shared Sabbatical began. We spent time discussing the idea of Sabbatical and the important role it plays in the life of a church and the longevity of a pastorate. We began to investigate all the little things that I do daily that keep this church running, things that would now have to be considered by members of the congregation. We formed an amazing Sabbatical Team to enable the work of the congregation. We enlisted the aid of a part time Sabbatical Pastor, Rev. Dale Parson. He agreed to work 20 hours/week focusing on pastoral care and worship duties. By the time July 31 rolled around, we were ready for our Shared Sabbatical to begin.

The first two weeks of August were spent in decompression mode, learning to explore the world without the constant pressure and worries of congregational ministry. It took me that long to disconnect from responsibilities, worries, and wondering what was going on "back at church." My wife and I took a trip to lowa the second week of August to see our daughter in a community theatre play. This trip was a big help in the process of decompression.

On August 28, I left U.S. soil to spend one month in San Cristobal de las Casas, Chiapas, Mexico. It was a very frightening endeavor. I had never been separated from my family for that long, and spending a month in a foreign country was a daunting idea. I rented an apartment and immersed myself in the culture of this city I have come to love.

Columbia United Church of Christ, through Global Ministries, has three mission partners in San Cristobal. I worked with two of those partners on Sabbatical. The Institute for Intercultural Studies and Research is the partner with whom I am most familiar, and the partner who hosted me. Melel Xojobal is the other partner I worked with. The Institute works primarily with adults, going into indigenous villages and hosting workshops focusing on practical skills, as well as theological reflection. Melel Xojobal ("True Light" in the indigenous Tzotzil language) works with urban children, going into the marketplaces and teaching them life skills and educational skills. Both agencies rely on support from the United Church of Christ through Global Ministries.

The 30 days I spent there were formative for me. I worked at The Institute 4-5 days/week for about 3-4 hours each day; the rest of the time was mine to spend reading, exploring, and praying. I spent many hours in prayer at various churches around San Cristobal. Many of the churches are almost 500 years old. Their architecture is impressive. I led worship twice, preaching in two indigenous churches. I also spent time in public areas: parks, marketplaces, and outdoor restaurants. These settings gave me a chance to interact with the people and learn from their context and to connect with myself and my faith. Simply walking through the marketplace was a religious experience for me.

Some evenings I joined the team from Melel Xojobal working with the children in the marketplace. As their parents and older siblings sell textiles to folks in the marketplace, the personnel from Melel gather the children together and play educational and developmental games with them, teaching them life skills and issues of personal dignity and security. I gathered with them several times on my trip.

As my time in San Cristobal came to an end, I became sad about leaving. I had come to love my new friends and new home and was sorry to see this time end, but I also missed my family and my church and looked forward to seeing everyone again. I was a bit torn, but was glad to be back in St. Louis in the early morning hours of September 30.

I returned to work on November 1, reconnecting with the church I love. As I reenter my ministry with all of you, my thoughts are on what the future will bring. We have accomplished much in the past five years, but what will the next five years bring? What will the next ten years bring? These are my thoughts as I return from Sabbatical: what do we want this church to be ten years from now, and what can we do today to make that vision a reality?

On **September 23-24, 1989**, Columbia United Church of Christ celebrated our 20th anniversary at this location. On Saturday, September 23, there was a fellowship dinner with reminiscence and good food. Rev. Jerry Jordan and his family returned, and many folks brought pictures of the past.

Sunday morning, September 24, 1989, the congregation celebrated again in worship. On that occasion, they also celebrated the joy of burning the mortgage on this building, a loan they had been paying off since 1969. In honor of the occasion, Ed Kaiser presented the church with a King Protea plant. This plant is the national flower of South Africa and has a unique quality. It not only survives, but thrives in the aftermath of wildfires.

When a King Protea plant is part of a wildfire event, the aftermath of the fire causes the seeds of the plant to be distributed across great distances. The young seeds take root in the burnt soil, and the nutrients from the burning actually aid in the new plant growth. A few months after a wildfire event, the ground is covered with King Protea plants. Ed used this analogy to illustrate the growth that he anticipated happening at CUCC in the aftermath of the mortgage burning. The nutrients of the fertile ground that had been prepared in those twenty years would lead to a great flowering of CUCC.

What happened next was incredible! This church grew, spiritually, as well as numerically. Rev. Brandenburg led this congregation in both celebrating the past and embracing the future. We learned to be a voice for justice and righteousness in our context. We remodeled the Sanctuary that year (1989) and added an educational wing (1999), as well as our LODO preschool ministry (2002). We grew in many exciting ways.

Fast forward to 2023. We are emerging from a wildfire of sorts in our world today, as well. The COVID pandemic has ravaged our country to a great degree, burning our entire culture to the ground in many ways. Now that the pandemic phase of our relationship with COVID is over, and we are in the managed phase (thanks to the COVID vaccines, God's divine intervention), we are rebuilding from the ashes. Like the King Protea plant, we have the opportunity to scatter our seeds to the winds, causing God's will to blossom and grow all over our context. In the ashes of COVID, the opportunity for new spiritual life is present.

In the past three years of pandemic, expressions of faith have changed greatly. Many people discovered a yearning for spiritual connection during this time and are now searching for a progressive faith expression such as ours. Others, who had been active church-goers prior to the pandemic, have drifted away from their faith. Our faith expression as a church has changed, most notably in our online expression but also in the way we interact day to day. We are growing and blossoming in the aftermath of the COVID wildfire.

We are now entering a new year. The year 2023 stretches out before us with hope and possibilities. This year for CUCC is very much like 1989 was. We will be introducing a campaign for Sanctuary remodel, just as this church did in 1989. We are celebrating an anniversary (100 years as a congregation), just as they did in 1989. And just like in 1989, we are rebuilding: not from the ashes of the mortgage burning, but from the ashes of the COVID pandemic.

It was expressed at that 1989 celebration that "the best is yet to come for CUCC," and in many ways, that was true. The following 15 years or so were a golden age for this church and for God's will being done in this context. I feel that we are entering another golden time for this church, and as we spend this entire year celebrating and blossoming, I think that phrase is fitting once again, "the best is yet to come for CUCC" as we celebrate our past and embrace our future. Come be part of the excitement!

The next ten years for CUCC will be critical. We will need to look at the ways we do church, the ways we finance our ministry, the ways we express our identity in the world, so we can emerge from the ashes of the COVID pandemic flourishing, like the King Protea. This will only happen with your support: financially, certainly, but more importantly -- time. When you give your time to God's work in the world through CUCC, you enable the ministries of this church to flourish.

What will emerge from the ashes of the COVID pandemic? That is up to you!

At our Congregational Meeting, Lydia Whitacre volunteered to fill the Nurture & Education Ministry Team Chair position, and Alethea Tennill volunteered to fill the Secretary's position.
