# INTRODUCTION

#### **PURPOSE:**

To provide leadership for the Council and Congregation, working to ensure that the Constitution and Bylaws are followed, that the Mission Statement is lived out, and that components of the Strategic Plan are executed; to foster a loving, Christian environment consistent with our stated Core Values.

# Highlights:

2017 was a historic year for Columbia United Church of Christ! So much changed in just a year and so many contributed to the change.

On June 11th, the congregation voted to call Pastor Rick Oberle as the next Pastor and Teacher of Columbia UCC. The Pastoral Search Committee: Chris Bach, Katrina Boogerd, John Graves, Jessica Lucas, Jamy Preul, Anita Sanderson, and Chris Schupp, worked tirelessly and faithfully to bring us a truly outstanding pastor and person who looks to be a wonderful fit for our congregation. Pastor Oberle officially began his ministry at CUCC on September 1 and received an enthusiastic welcome.

I remain thankful for the interim ministry team and the past two Councils who led, cared for, and revitalized the congregation while preparing us for our next called pastor. Pastor John Bracke ended his interim ministry and Mary Bracke ended her music ministry on June 30. Pastor Ken Beckmann continued calling on parishioners and Steve Buchholz continued serving from our pulpit until Pastor Oberle's arrival. I am personally grateful for all in the congregation who helped keep the church functioning during the two months this summer between Pastor Bracke's departure and Pastor Oberle's arrival.

Several new staff were hired this year. Kristin Veteto stepped in as Music Coordinator and Choir Director and Jonie Loehnig began as Organist, Pianist and Accompanist. Both have brought wonderful gifts and talents that have enhanced the musical experience at CUCC. With gratitude, we said goodbye to Joan Williams, but were excited to welcome April Rothweiler as our new Office Administrative Assistant.

On May 21st, the congregation voted to enter into a formal Open and Affirming process to determine whether Columbia United Church of Christ will become an Open and Affirming congregation. The process will commence next month; details are available elsewhere in this report.

As recommended by the 2016 Vision Team and carried out at the direction of the Council, several church upgrades were made in 2017. The most visible were the two new television screens in the Sanctuary and the new furniture and overall makeover of the Gathering Area. Less visible was the long overdue upgrade to our office computer system. This fall, the congregation overwhelmingly voted to repurpose the Building II Fund to help pay for future select upgrades to the lighting, finishes and furniture of the Sanctuary, Fellowship Hall, and Library.

I couldn't have asked for a better Council. We functioned at a very high level and approached each issue with great thought and care. I will remain forever grateful for their efforts, support and grace. Of note, the Council completed the work of the revitalization committees including finalizing and enacting the outstanding policies and procedures except for the Emergency Plan which should be completed later this month.

It has been a joy, privilege, and honor to serve as your Moderator during this exciting eventful year. The work has brought me closer to this congregation and closer to God. I am thankful that as I complete my tenure, CUCC has emerged stronger than a year ago. As written above, we have enjoyed many positive changes. In addition, thanks to you, attendance is up considerably, and the budget will have a modest surplus. I remain enthusiastic about the future of CUCC! We have a strong Mission Statement, an exciting, forward thinking Strategic Plan, and the pastoral and lay leadership and congregational resources to live out our Mission with integrity and love. We are a special group of God's people, and CUCC is a healthy, loving, and much needed faith community. I hope that each and every one of you will strive to make CUCC a greater part of your lives this coming year and beyond. See you on Sunday!

# Columbia United Church of Christ Congregational Meeting Minutes November 12, 2017 11:35am

Call To Order: 11:35

Budget: Steve Keithahn opened the annual Congregational Meeting to discuss the budget. Steve discussed four separate funds. He stated the Memorial Fund has been utilized in 2017 to help fund sanctuary upgrades. He mentioned the Memorial Education Fund that is monitored by a committee separate from Council. Steve mentioned the newly set up Organ Fund that will be utilized to collect the remainder of the money owed for the newly purchased organ. When that money is received the fund will go away as it is no longer needed. Lastly, he mentioned the Building II fund. This fund was created when the building expansion took place in the 1990s. The idea was that the next phase of construction would be to build a multipurpose building and this fund was set up to go toward that construction. Currently, there is over \$71,000 in Building II fund. Donations have been given to this fund over the years but most of the money was collected years ago. Over the last couple of years Councils have discussed this fund to see if it could be repurposed into a fund designed to rehab and upgrade our current facility. It was also discussed that a multipurpose building isn't in our current long range plan.

Motion to rename the Building II Fund to the Building Maintenance & Upgrades Fund was introduced by Ed Kaiser and seconded by Jim Loveless. The motion carried by a ballot vote of 66-1.

Christine Staelens introduced the budget for 2018 and discussed the main changes from last year's budget. Among those changes include a new line item for Computer Maintenance, a new line item for cleaning service, OCWM payment increase, a new line item for Open & Affirming Committee, a new line item for special missions. Christine thanked the members of the committee that helped prepare the budget: Jim Loveless, Barry Kirchhoff, Paula Wilson, and Charles Marcks.

**Question:** Cliff Beckman asked if these will be ongoing budget line items. Answer: that will depend on the goals and visions for next year.

Motion to pass budget proposed by Jim Loveless and seconded by Llona Weiss. Motion carried by hand vote.

# OVERVIEW OF 2017 FINANCIALS / TREASURER \_\_\_\_

**PURPOSE:** To assist the church council by maintaining financial records and providing monthly management accounts to assist in financial decision making.

We entered 2017 with great hope as we anticipated calling a permanent pastor. The budget for 2017 was fairly conservative as we did not know the timing of the new pastor's arrival. As always, our members continued their generous support of the church and its programs. Below are some financial highlights for 2017:

Cash and investments increased by \$73,824 over December 2016, an increase of 23%. Actual Joyful Giving met our budget goal and was an increase of 3.24% over 2015 levels. Our budgeted expenses for 2017 were \$277,650 and our actual expenses were \$267,349 resulting in excess income over expenses of \$19,246. Administration expenses were \$3,583 over budget which included updating our computer system in November. Building and grounds was over budget by \$1,403 due to higher utility expenses and elevator maintenance than budgeted. Christian Education was under budget by \$2,272 due to lower UCC College Student and Youth Ministry expenses than budgeted. Additional Leadership was under budget by \$1,186 due to vacancies in positions during 2017. Pastor expenses are over budget by \$1,012 due to payment of pension and insurance for 2018 before the end of the year. These invoices were due by January 1 and we report on a cash basis. Search committee expenses were under budget by \$9,266 due to lower relocation expenses than budgeted. Staff salary expenses were over budget by \$1,918 due to higher FICA and unemployment insurance than budgeted. The unemployment estimate has been corrected on the 2018 budget. Worship expenses were under budget by \$3,797 due to lower music program and non-music program expenses than budgeted.

The 2018 budget was approved at the November congregational meeting.



# BUILDING & GROUNDS MINISTRY TEAM \_

**PURPOSE:** To meet accessible requirements; to protect our investment in the assets of the church; to provide a comfortable, clean and safe place to carry out the programs of the church; to provide access to the church; parking for staff and participants; an aesthetically pleasing environment; to provide comfort, security, safety and sanitation; to keep assets in condition and repair.

# Activities and Highlights

The Gathering Area has new furnishings, including seating, tables and lighting, that were completed and paid for in 2017. New entryway rugs were added. A new credenza and sofa table were added in the Gathering Area for serving coffee and snacks. Two large screen video monitors were added in the sanctuary to enhance Sunday morning worship. A new commercial dishwasher was installed in the lower kitchen. A new intercom/video doorbell was added to 2 basement entryways. All outside doors were re-keyed to upgrade security. New computers have been purchased for the church office and the pastor, and new fiber optic internet service was also added. A new commercial vacuum was purchased to replace the old one that was worn out.

Thank you to the lawn mowing crew who year after year keep the property looking good. Thanks to Brent and Charlie Marcks who purchase and replace the filters as needed on our heating and cooling units. Thanks also to Mike Rapp for his ongoing attention to the lighting and electrical upgrades as needed. Thanks to Cliff Beckman for refurbishing the CUCC sign at our entryway. Thanks also to Lloyd Viehland for all he does, many times above and beyond what is expected, including some remodeling and painting of the youth lounge, needed because of a large increase in the number of youth attending on Sunday mornings!

Lastly, but not least, thanks to Men's Fellowship for their support and help on the many projects undertaken in and around the church.

We have several projects that are on a list of "to do" in 2018. Some projects are carryovers from 2017 such as upgrading the lighting and ceiling in the fellowship hall, a new lighting system in the sanctuary, including spot lights for performances, new seating for the library, and possible new tables and chairs in the fellowship hall.

# OUTREACH & ADVOCACY

**PURPOSE:** To coordinate and encourage participation in local outreach activities; promote organizations included in the annual Outreach budget; promotes support for Our Church's Wider Mission and the special offerings of the United Church of Christ; identify non-partisan issues for which advocacy may be appropriate.

2017 was a busy year, and many CUCC members and friends contributed their time, talents and treasure to support outreach efforts. Some highlights:

# Special Offerings and Contributions

CUCC was again a "Five for Five" congregation, supporting all 5 UCC campaigns—Our Church's Wider Mission, One Great Hour of Sharing, Strengthen the Church, Neighbors in Need, and the Christmas Offering (Veterans of the Cross). # **Budgeted Support for Service Agencies**

# Gathering Supplies and Gifts

CUCC participated in several collection drives, including school supplies for the Family Impact Center; warm coats and hats for Warm Up Columbia; paper products and school kits for the Festival of Sharing; and Christmas gifts and food money for the Voluntary Action Center Christmas Campaign. Volunteers took responsibility for collecting and delivering all these items.

#### Faithful Service

Many CUCC groups and faithful individuals worked packaging food at the Food Bank the second Tuesday of each month. Crews of church members and friends served meals to the homeless and needy each third Monday at Loaves and Fishes (Wilkes Blvd. Methodist Church). A diligent crew cleaned up I-70 Drive NW near the church on Clean Up Columbia Day in April.

The Core Team consists of Katrina Boogerd, Bryan Crousore, Mark Duncan, Peter Jaberg, James Melton (co-chair), Tricia Price (secretary), Elaine Trout, Llona Weiss, Steve Keithahn (co-chair), and Pastor Rick Oberle. After much reflection and in consultation with Pastor Oberle, the Council decided to postpone beginning the open and affirming process until 2018 as the Council agreed that the top congregational priority was to help Pastor Oberle settle in as the new pastor. The Core Team met several times this fall to determine the next steps to offer our congregation as we seek to be more open and affirming to all of God's Children.

We will be using the term "Inclusion Initiative" often. We feel that this term is most representative of the journey we are on. # STAFF REPORTS

# PASTOR'S REPORT

"...they devoted themselves to the apostles' teaching and fellowship, to the breaking of bread and the prayers. Awe came upon everyone, because many wonders and signs were being done by the apostles. All who believed were together and had all things in common; they would sell their possessions and goods and distribute the proceeds to all, as any had need. Day by day, as they spent much time together in the Temple, they broke bread at home and ate their food with glad and generous hearts, praising God and having the goodwill of all the people; and day by day God added to their number those who were being saved." -Acts 2:40-47

This has been a year of change and excitement for the Oberle family. Last year at this time we were firmly ensconced in our home of ten years, the community of faithful Christians in Bem (Owensville) Missouri. Then, on Friday, January 13, 2017 I received an email from Chris Bach (Search Committee Chair) that set the wheels into motion that brought us here. The journey of 2017 was an emotional roller coaster for all of us; but as I reflect on it I see evidence of God's hand at work. As the Search Committee was guided to investigate me based on my profile and I was guided to examine the possibilities of new ministry in this place, God was the guiding force directing us; and God has brought us together for many years of very focused and intentional ministry together.

My life has been a journey of renewal and exploring new ways that God has called me to live. Giving up a promising career in the secular world to go to graduate school (Seminary); a city boy moving to the middle of the woods (Bem) for my first solo ministry setting out of Seminary; uprooting my life to come to Columbia and explore the possibilities of new ministry here; and even beginning my Doctoral work at Eden Seminary last year; all of these have been movements of renewal and exploration of new things; and all have been possible when I decided to let God be "in charge" and follow God's guidance in my life. When I stopped trying to control things by putting conditions on God's guidance and just let God lead me, great and wonderful things happened in my life. Certainly, moving to Columbia and accepting the call to be pastor of Columbia UCC was one of those great and wonderful movements in my life.

We are thrilled to be here! What I have found these past four months is a church that embodies the vision of how Christians are called to be articulated in Acts 2:40-47 (quoted above). The community of nascent Christians that is developed in the early chapters of the Book of Acts is a community that is so empowered by the permeance of the Holy Spirit in their bodies and in their midst that they devote themselves fully to God. They devoted themselves to God's teachings, spent much time together in the Temple (church) celebrating fellowship together and praising God; and most importantly, they had the goodwill of all people in their hearts. They also did God's work, caring for the sick and the poor, giving fully of themselves to help those in need. I often tell people that if they want to know what church should be, look at Acts 2:40-47. I see many of these characteristics at Columbia United Church of Christ; and a potential to live even more fully into these qualities.

As I began my ministry here, I had four goals in mind for my first few months.

Intentional visits with congregation members; making a pastoral connection

Working with the youth and empowering their ministry

Developing transformative worship in an intentional way...

Establishing an effective administrative team and set of administrative resources

These four issues have been the focus of my work the past four months.

I have tried to be very intentional about visiting members, especially homebound members; although I would have liked to have done even more visits early on. One great blessing in October were the home visits the Membership and Care Ministry Team coordinated. In 2018 I am even more focused on visiting our homebound members with greater frequency, bringing the light of the church to them where they are.

I have worked with the youth, both Middle and Senior High. I continue to visit their classrooms most Sundays, and have organized several events for both ages. In 2018 I hope to enhance this even further, working with the Nurture and Education Team to put together a task force of adults who will work with both Middle and Senior High, assembling a comprehensive schedule of events, providing chaperones and mentors, and developing a vision for what we can do to meet the needs of our youth.

I have been working on new and creative worship ideas with Kristin Veteto, our new Music Director. Transformative worship basically means worship that sticks with you after Sunday morning is over; transforming your life in meaningful ways. This could be through hymns, anthems, sermons or other readings/skits. Transformative worship involves trying new things; experimenting with different ways to do what we always do (like new models and practices for serving communion). I continue to try new things, making worship transformative and experimental, an exciting way to encounter God every week. Kristin, Jonie, the Worship and Music Ministry Team, Worship Leaders, the Celebration Singers, Chapel Ringers, and so many others make up the team that enable us to have transformative worship at CUCC; and to them all I give thanks!

Establishing an effective administrative team and set of administrative resources has been the component of my job that has taken considerably more attention than I anticipated. However, the administrative tasks that have taken my attention have developed into many fruitful ministry benefits. Most important of these tasks was the hiring of our new Administrative Assistant, April Rothweiler. Much of my first month at CUCC was taken with reviewing resumes (we received 60+), interviewing applicants on the phone (12), interviewing applicants in person (6), and selecting just the right person. April has been a blessing to my ministry and the ministry of CUCC as she takes the initiative and does the work that needs to be done.

I have been working on staff development with the rest of the CUCC staff. April, Kristin, Jonie, Lloyd, Erika and I meet every Monday to work on developing our team and enhancing the ministries of CUCC. I have been especially intentional about including Erika (Maltsbarger, our LODO director) in our staff development and working with LODO. This important ministry of CUCC is one that we will continue to recognize as a blessing in our midst, and one great way we are being in ministry in our community.

Shortly after hiring April, we began looking at upgrading our administrative resources, including our office computers and software, which were well past their life expectancy. Christine Staelens, April and I interviewed three local companies, obtaining bids from them and selecting the one that best meets our needs. On December 13 our new computer network was set up giving us a dedicated server and workstations that operate off that server. When the installation is complete we will have daily backups of all our data and cloud storage of our information; a component that was lacking. The upgrades to our administrative resources will enable us to be more intentional in our ministry work; and run a more effective office.

Much has been accomplished in just four months; but there is much yet to do on the horizon. My 2017 goals have just begun; more refinement and concentration will take place in 2018 as I continue to work on making pastoral connections with congregation members, empowering and affirming our youth, creating transformative worship, and developing our administrative staff team and resources. But I also plan to adopt a few new goals for 2018 as well. Those include:

Developing a Senior High Ministry/Ministry Team

Developing a Middle High Ministry/Ministry Team

Developing a College Age Ministry/Ministry Team

Developing rubrics for our Christian Education Program

Developing parameters for welcoming and inviting guests to CUCC

Encouraging our Mission Work and Developing a Ministry with Chiapas, Mexico

Supporting our CUCC Inclusion Initiative (Open and Affirming)

As you can imagine, these are not goals that I can accomplish myself. I would not attempt to try. We are all part of a great Ministry Team at CUCC, the vision of the working church that is articulated in Acts 2. I have articulated these goals over the past few months with the Ministry Teams who hold responsibility for these initiatives, and they are excited. These are common goals we can share, enabling God's work in this place.

However, for these goals to begin we all need to work together. We will be looking for more people to join existing Ministry Teams and new task forces to enhance what we are already doing and grow into a great source of blessing for the Columbia community. We must all work together to accomplish these goals; for we are one family, united in faith and dedicated to serving God.

The community of Acts 2 spent much time together, praising God through worship, education and service. In other words- they showed up, and they dedicated themselves to God. Council Moderator Steve Keithahn emphasized in his January Communicator article the importance of showing up. I have been impressed by the increase in worship attendance in the four months I have been here; but I also worry that that will decrease when I am no longer "new". As one family of faith it is incumbent upon us to show up and dedicate ourselves to God. As we work together, as we learn together, as we serve together our efforts are enlivened by the presence of each person. Many hands make the workload light, it is true; but more importantly, many hands increase the joy.

This year, as the CUCC Ministry Teams and I work towards the goals I have articulated in this article, both the new 2018 goals and the continued 2017 goals, I encourage you to participate in one of our Ministry Teams. Participation can be through meetings and planning, or even just by adopting a Ministry Team task as your special area of responsibility. The benefits of participating in this divine work far outweigh the opportunity cost of secular conflicts. We are a on a great journey together; come and join in the fun! Embrace that vision of the ideal church community articulated in Acts 2; and let the Good News of Jesus Christ be the focus of your life.

Confirmation class is going well with six 8<sup>th</sup> & 9<sup>th</sup> graders participating. The dialogue is lively, and the youth are enjoying this foundational faith experience. Classes meet on Wednesdays at 7:00pm.

Our youth got together for social events at Pastor Rick's house in October. Pastor Rick hosted the Middle High on October 7 and the Senior High on October 14 for pizza, games, pumpkin carving and movies. On October 20-21 the youth went to the Festival of Sharing in Sedalia for mission work and fellowship together.

The Senior High worked at the Food Bank on November 14, and went to Shakespeare's Pizza and the Hickman High School Play on November 16. Ally Jaberg was in the play and we all cheered her on! On December 10, both groups participated in a Scavenger Hunt at the Columbia Mall.

We have several activities already scheduled for early 2018, including a lock-in at church on January 26-27, a Souperbowl collection on February 4, a Senior High event February 17-19 at Camp MoVal, work at Ronald McDonald House on February 25, and youth leading worship one Sunday in March. Two youth are going to be participating as worship leaders for Pastor Rick's installation on January 21.

Moving into 2018, we plan to work with the Nurture and Education Team to put together a team of CUCC members who will work with our youth, putting together a comprehensive program focused on Education, Service, Worship and Fun. By August, we hope to have a schedule for the 2018-2019 year that embraces these aspects, planning ahead so youth can incorporate these activities into their calendar.

We also are planning Mission Trips for our youth this summer. Tentative dates are July 15-18 for Middle School, and July 22-26 for High School. The Middle School trip will be to St. Louis, working with a UCC Congregation there participating in various mission activities. The specifics for the High School Mission Trip are not set yet; but will be by the end of January.

Many people consider youth as the church of tomorrow; but the reality is that they are the church of TODAY. Empowering them to take ownership of the church ensures that the faith we proclaim is inclusive of all the people; and Christ's ministries through the church are enlivened by our youth.

A comprehensive Youth Ministry will need involvement from committed CUCC adults to thrive. Look for information in the weeks to come about ways that you can be supportive of these endeavors. Mentors, sponsors, chaperones, supporters- there is a role for everyone in nurturing our youth. This will be a high priority in 2018, so we hope you will join in the fun!
